#### **CALL TO ORDER**

The meeting was called to order by Chairman Max Wilson at 5:39 p.m.

## **MINUTES**

Christine Allen motioned to approve, Rick Lewis seconded, Motion carried.

#### **NEW MATTERS**

- 1) Discussion of the Midwest City Council Chambers ADA Retrofit Feasibility Analysis dated May 19<sup>th</sup>, 2020
  - a) Brandon presented a brief overview stating that the contract for construction drawings would be going to Council next week. Chairman Max Wilson inquired about the timeline. Brandon noted it is a difficult time for budgeting. Christine Allen inquired about Council Chamber seating capacity and grant funding.
- 2) Discussion of the Tribute to Liberty
  - a) Grace Filer inquired about what ADA Committee members would like to have at the event. Vice

Chairman Rick Lewis asked for a spotlight on the interpreter, reserved spots with good visibility, and concessions along the wheelchair path. Chairman Max Wilson asked for the cross-walk to be cleared of cables and water and stated that he would like to walk the path prior to event with Grace Filer. Clint Reininger asked for a visible interpreter on the stage with direct lighting and easy access to portable restrooms and vendors.

- 3) Discussion of projected budget funding for ADA projects FY20-21
  - a) Brandon gave a brief overview of current and planned projects. There was general discussion regarding funding
- 4) Discussion of current transition plan priority list
  - a) Brandon gave a brief overview. Focus has been on Council Chambers. List of updated priorities to be provided prior to November ADA Committee Meeting.
- 5) Discussion of accessibility with MWC jail
  - a) Brandon reached out to Police and there have been no complaints. MWC jail has agreements with other ADA compliant jails.
- 6) Discussion of accessibility with MWC playground equipment
  - a) Brandon gave a brief overview. New parks will be ADA compliant.
- 7) Discussion of accessibility in Joe B. Barnes Park including softball, tennis court, and Swim and Slide areas
  - a) Patrick Menefee gave a brief overview. New softball facility will be ADA compliant. Existing facility is not being renovated due to future closing of the old facility.
- 8) Discussion of the project to add a cut through in the West parking lot of City Hall
  - a) Brandon gave a brief overview. City has received a quote for the work but does not have construction funds.
- 9) Discussion and consideration of a status report of Midwest City's Trail Projects funded through ODOT
  - a) Brandon gave a brief overview. Palmer Loop is funded. Trail phase 2 and 3 is being designed and will be bid as funding allows.
- 10) Discussion and consideration of a status report of the Midwest City ADA Transition Plan.
  - a) Brandon gave a brief overview. Chairman Max Wilson stated that good progress is being made but more action needs to be taken on small projects that have a big impact
