for temporary signs when access to property is restricted by public construction project.

These amendments are needed to assist residents locate the entrance to the commercial property.

AN EMERGENCY ORDINANCE AMENDING SECTION 9-391, "TEMPORARY SIGNS" OF THE MIDWEST CITY MUNICIPAL CODE BY THE ADDITION OF AN EXEMPTION FOR TEMPORARY SIGNS WHEN ACCESS TO PROPERTY IS RESTRICTED BY PUBLIC CONSTRUCTION PROJECTS.

WHEREAS, from time to time public construction projects restrict access to commercial properties within the City of Midwest City; and

WHEREAS, such limited access may result in a loss of revenues or business by the property; and

WHEREAS, attempts to locate the entrance to the commercial property distract drivers, resulting in risk to the public; and

WHEREAS, the Mayor and City Council of the City of Midwest City find that it is in the interest of the public health, safety and welfare that a directional sign be permitted:

NOW THEREFORE IT IS ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MIDWEST CITY:

Section 1: Section 9-391 "Temporary Signs" is amended by the addition of subsection (j) to read as follows:

One temporary directional sign per business of eight (8) square feet may be erected no closer than twelve feet to the curb line at the entrance to the business when access to the business has been partially or completely blocked due to a public construction project when the access will be impeded in excess of seven (7) days. The sign shall contain only the "name of the business" and the word "entrance," or a direction arrow. It shall be removed within 48 hours after the project has been substantially completed as determined by the City. A permit shall be required, but the fee shall be waived. All other regulations of this section shall be followed.

Section 2: SEVERABILITY. If any section, sentence, clause or portion of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of

the ordinance.

<u>Section 3: Repealer.</u> Any section, subsection or portion thereof in conflict with this ordinance is hereby repealed.
