16 17	All regular meetings of the council of the city shall be held at or after 6:00 p.m., and shall be held as follows:
18	(1) There shall be only one (1) regular meeting, in the months of November and
19	December, which meeting shall be held on the second Tuesday;
20	(2) There shall be only one (1) regular meeting in the months of February, March,
21	April, July, August, September and October, which meeting shall be held on the fourth Tuesday;
22	and
23	(3) There shall be two (2) regular meetings held in January, May and June, which
24 25	meetings shall be held on the second and fourth Tuesday.
26	If the date of a regular meeting falls on a holiday recognized by the city, that meeting shall be
27	held on the next day that is not a holiday.

29	Section 2. REPEALER. All ordinances or parts of ordinances in conflict herewith are hereby

32	Section 3. SEVERABILITY. If any section, sentence, clause, or portion of this ordinance is for
33	any reason held to be invalid, such decision shall not affect the validity of the remaining provisions
