ORDINANCE NO. 3428

AN ORDINANCE AMENDING THE MIDWEST CITY MUNICIPAL CODE, CHAPTER 11, CITY EMERGENCY MANAGEMENT, SECTION 11-4 FACE COVERING AND SOCIAL DISTANCING DURING "COVID-19 PANDEMIC EMERGENCY"; PROVIDING FOR REPEALER AND SEVERABILITY AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF THE CITY OF MIDWEST CITY, OKLAHOMA:

EMERGENCY ORDINANCE

SECTION 1. The Midwest City Municipal Code, Chapter 11, City Emergency Management, Section 11-4 Face Covering and Social Distancing During COVID-19 Pandemic Emergency is hereby amended as follows:

Expiration of Ordinance

This ordinance shall expire if less than 5% of the tests in Oklahoma County are positive for more than two consecutive weeks.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. SEVERABILITY. If any section, sentence, clause or portion of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance.
