PROCLAMATION REGARDING MODIFICATION OF ORDINANCE 3406 CITY OF MIDWEST CITY, OKLAHOMA

WHEREAS, on March 20, 2020, Ordinance 3406 was passed by the City Council of the City of Midwest City; and

WHEREAS, on March 24, 2020, Ordinance 3406 was modified by the City Council of the City of Midwest City; and

WHEREAS, the Ordinance was addressing the state of emergency declared by the Governor of the State of Oklahoma on March 15, 2020 for all seventy-seven (77) Oklahoma Counties; and

WHEREAS, Ordinance 3406 was in effect until April 30, 2020 based on the City Manager's Proclamation of April 6, 2020, pursuant to the Governor's Executive Order 2020-13, was modified on again on April 23, 2020 by Proclamation of City Manager setting out requirements for businesses to reopen, and modified again by the City of Midwest City's City Council on April 28, 2020;

WHEREAS, the Governor has released an Open Up and Recover Safely Three Phase Approach to Open Oklahoma's Economy; and

WHEREAS, the requirements for all the Phases listed in the Governor's Open Up and Recover Safely Plan were met and the need for the restrictions listed in the City of Midwest City's Emergency Ordinance 3406 expired on June 1, 2020; and

WHEREAS, after a period where the rise in new cases subsided, the increase in new cases and positive testing percentages has resumed at the end of June, 2020, and remains at an elevated level relative to previous phases of the pandemic; and

WHEREAS, since mid-June, hospitalizations have consistently remained at an elevated level that causes concern to public health officials; and

WHEREAS, recent scientific and data-based investigations by OCCHD have successfully identified targeted areas where safety measures will substantially improve the City's response to this pandemic, preserving the health of the community; and

WHEREAS, the owner and/or operator of any establishment upon which premises any of the violations of this ordinance occurs will be in violation for allowing such offense to occur upon the premises and shall be fined an amount not to exceed \$200.00 and may have its municipal license or permit revoked or suspended for a period of time up to one (1) year; and

WHEREAS, the Ordinance allowed the City Manager or his designee to extend or reduce the length of the implementation of the restrictions and penalties set out within the Ordinance; therefore this will be in effect until September 30, 2020; so

NOW, THEREFORE, the City Manager of the City of Midwest City, Oklahoma pursuant to the authority vested in him by the City Council as set out in Ordinance 3406, takes the following actions: Ordinance 3406 shall require all on-premise staff in restaurants, breweries, wineries, taverns, shopping mall food courts, food halls, cafeterias, bars, night clubs, and any other food services must wear facial masks or coverings while on duty.

Public notice of this proclamation shall be given to and filed with the City Clerk of the City of Midwest City.
